The Registered office of the Trust shall be at Jehanabad, Bihar , The registered office may be shifted to such.

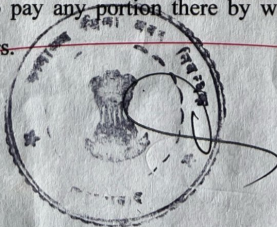
Other place as the Trustees may decide time to time

For the fulfillment of its objective the Trust may enter into agreement with the Companies, firms and/or other institutions.

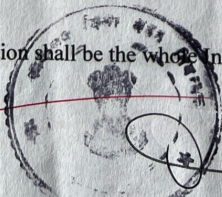
To accept the management of any trust Shall have also the power to frame rules and bye laws under its constitution.

Minimum number of Trustees shall be Five and maximum number of member shall be seven subject to approval from Board of Trustees.

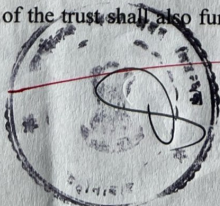
The Trust shall be irrevocable.

This in pursuance of promised, the author and the trust as settler both hereby convey unto and settle upon the Trustees and all the cash here to hold the same upon trust and the Trustees both here by admit and acknowledge the transfer there to them with power and subject to the use mentioned here in after.

1. The name of trust shall be "ANR Educational Trust" a Public Educational trust, with its resistered office at Hajipur, Jehanabad.
2. The trust has been established for the purpose and objective lay down above.
3. The author of the trust shall also function as a member of the board of Trustees.

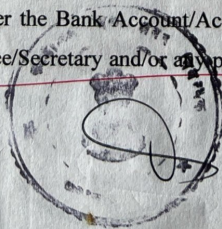
4. The trustee shall stand possessed of the cash. Here by conveyed and settled upon and shall use and apply the interest. The profits and the other income derived thereby for the purpose and objectives of the as aforesaid.
5. The case here by conveyed to the Trustee shall form the corpus of the trust property. but Trustees shall have power from time to time to increase or decrease the corpus. According to the best of their judgment.
6. The trust shall be governed by a board of Trustees. In the event of death, incapacity, insolvency, resignation the remaining trustee shall be entitled to nominate any other person as they think fit and proper to act as trustee in place of the trustee so died incapacitated, declared insolvent resigned or refused to act as such.
7. The nomination of any person as a trustee shall be either unanimous or by a majority decision and in the event of the Trustees being equally divided on the nomination of any person, the decision in the matter of the Managing Trustees shall be final and conclusive.
8. The administration of the trust here by constituted and the entire control, supervision, regulation, management of the trust property and even the application of the entire or a part of the income and the profit there of as also of all the donation and contributions and subscription, if any received by it shall vest in the uncontrolled discretion of the board of Trustees subject however always to the provisions contained as here in before.

10. The Board of Trustees shall have power to accept donation. Contribution grant or subscription from others in cash or kind with or without any special conditions attached there to provided that any such condition does not contravene the provision of clause 2. here of Subject to the same restrictions. The board of constituted trust has declared.
11. The Board of trustees may elect on nominate any one of them as the Managing Trustee/Secretary for any period of time. The first Managing Trustees/Secretary shall be Mr. Ajay Kumar Singh and he shall hold that office and position up to the time of his death, incapacity, insolvency, resignation or refusal to act as such.
12. The First meeting of the Board of Trustees shall be held within three months of the date of the execution of this deed and shall be summoned by Author of the trust by giving at least seven days' notice summoned by Author of the trust by giving at least seven days' notice in writing to all the trustees held at such place and time as may be specified in the notice and in that meeting all relevant matters relation to the trust shall be considered in all possible details and particularly the ways and the manner to give effect to the provision of the deed of trust to attain the object an purpose of this trust.

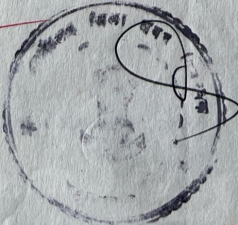
14. The Trustees may in their uncontrolled discretion deposit for safe custody and documents or securities relation to or forming part of the trust property with the bank or banks as a foresaid on payment of such charges therefore, if any as may be agreed upon and found expedient in the interest of the trust.
15. Meeting of Board of Trustees may be held at such time, at such place and on such dates as may be agreed upon by the trustees. Such meeting may be summoned by managing trustee or any one or more of the trustees by giving at least 21 (twenty one) days notice in writing.
16. The Accounting year of the Trust shall be the financial year ending on 31st March every year.
17. If the Trustees differ with one another in respect of any such matter with reference to which they enjoy discretion the opinion of the majority of the trustees present or voting at the meeting shall prevail and shall be binding on all the trustees, and in the event of the trustees being equally divided the view taken by the managing Trustee shall prevail in deciding such matter.
18. The objects of the Trust shall be such of those that will make it eligible for exemption from income Tax under the provisions of income Tax Act. 1961 as amended from time to time.
19. The Board of Trustees may appoint constituted attorneys or agents and to delegate such attorneys or agents all or any or the powers vested on them under these present and from time remove such attorney or agents and to appoint in his or their place.
20. With the consent of Board of trustee in absolute majority, any clause of the trust may be amended/changed in the larger interest of the Trust.
21. It is hereby declare that the Trustees have power to wind-up the trust by merging or amalgamating with another Trust or Charitable society having similar objects.
